- A. In October of 2023, our Title I Annual Parent meeting will be held to inform parents of West Charlotte's participation in Title I. Parents are notified via school website, ConnectEd message, ParentSquare, Social Media, and Remind. The meeting will be virtual and recorded in order to offer flexibility to the parent's schedule. Interpreters/translators will be provided.

the day to accommodate flexible scheduling to meet the needs of our parents working a variety of schedules.

Additionally, we conducted a Family Empowerment Survey at the beginning of 2023-2024, asking parents and family members about times and days that were most convenient for them. This survey data will be used to guide decision-making with regard to times for Family Empowerment nights and methods of delivery of information to families.

A. Parents will be involved in an ongoing and timely way in the planning, review, and improvement of the Title I Parent and Family Engagement Plan. The SIT, PTSA, and Parent and Community Engagement Committee will collaborate to promote opportunities for parental involvement and engagement.

There will be multiple opportunities for parental involvement and engagement throughout the year including our Family Empowerment Nights as well as program-specific parental engagement nights such as the IB Pinning Ceremony and Senior Information Night in the Fall and Spring.

Our school is taking steps to ensure that families are empowered and engaged in an equitable way. To achieve this, we are creating a Family Empowerment Committee, which will be led by our family advocates and our partner SchermCo. The committee will help families facing unique challenges and in vulnerable situations stay informed and engaged with the school happenings.

WCHS parent and community engagement committee along our school's PTSA are developing more training opportunities to help parents work with their child (literacy training, computer skills, homework assistance/workshops, family literacy nights, adult EL, GED etc.) Currently, WCHS partners with Community In Schools, host Curriculum nights, IB and AP meetings, and FAFSA night to provide assistance and address the needs of their child.

At the beginning of the 2024-25 school year, WCHS and SchermCo collaborated to conduct a Family Empowerment Survey. The survey aimed to identify the resources needed by families to support themselves and their students. The survey options included financial literacy, mental health support, job training, SAT Prep, Academic support, college access, etc. Based on the top three responses, we partnered

with SchermCo and community partners to provide support for families through our family empowerment nights to support their requested needs.

- 4. WCHS parent and community engagement committee along with our school's PTSA will coordinate and integrate parental involvement programs and activities continuously throughout the school year.
