### Principal's Report- Ms. Dyson

- Out-Teach for the Spring-Ms. Dyson applied for a grant to have an out-door learning space Other schools in CMS have also participated in this opportunity. The school collaborated with Ms. Storey (ecology teacher) to discuss ways to best use this space being that one of the requirements was that a teacher must use this space for learning.
  - Servant Church- Metro has partnered with Servant Church in addition to Out-Teach. Servant Church will have volunteers that come over to the school in February to work on cleaning out and preparing the courtyard for the Out-Teach project.
    - **Applied for Grant, Participant fee of \$5,000-** Ms. Dyson has applied for this grant.

### • Teaching and Learning

- Peer Observations- The ILT team worked together to create peer observations guidelines and practices. This was presented to staff during the January Staff meeting. Teachers were able to select the peer to observe. Through this process, teachers will observe each other, record their feedback conversations, and learn from each other.
- Best Practices for TA's PD- The upcoming workday is optional for TAs.
   Metro created professional development for teacher assistants that would like to work on that day. The professional development will be on taking student data, behavior practices, and more.
- 1/25 Professional Development Plan- Teachers will participate in various professional development as well such as writing IEPs and familiarizing themselves with the ECATs system. We are also having a CPI training where we focus on ways to de-escalate severe behaviors.

## School Upgrades

- Media Center-The media center will be getting a furniture upgrade that will help with more flex seating.
- Creating an Intervention Lab-After seeing the success with our OSTT program, Metro is working to create an intervention lab where this space will be utilized to enhance lessons and help to continue to grow our students.
