## IV. Principal Report - Becky Crawford

- a.) Celebrations and Summer Recap-Move to one campus Being together is amazing; Dragon House with all six grades was wonderful; Dragon of the Week starts next week; EOG results came out - SO PROUD to be an A school; SPARK is going well - assembly coming up; So appreciative of flexible staff as we have made schedule changes and worked out beginning of year kinks
- **b.) Events** (Kindergarten Parent Coffee) very well attended K Parent coffee great way for parents new to the area to connect
- c.) School Improvement Plan (SIP) Becky Crawford reviewed last year's end of year data which drives the goals for the School Improvement Plan. K-2 students composite 94% of K-2 students meeting or exceeding DIBELS expectations; 3-5 students EOG Composite = 86.4% of our students in 3-5 are proficient on EOG (levels 3,4,5); 76.2% at CCR (levels 4,5); Looking at growth: Reading = 77.4% → 82.4%; Math = 82.7% → 88.4%; Science = 83.9% → 92%; Composite: 86.4% = A; CMS strategic plan goals were shared now includes a K-2 goal; Our goals: duty free lunch; duty free planning; positive school climate; moving DIBELS from 94% to 96%; moving CCR from 67.5% to 70%; reduce %age of aggressive behaviors; retain 95% of teachers who remain in the profession and area; increase Math GLP; Indicators and action steps were reviewed: principals monitor instruction; MTSS tiered levels of instruction; instructional teams develop standards aligned units; attending to students' social and emotional states; school communication. Safety Plan was reviewed with the team.
- **d.)** Comprehensive Plan Next thing is the board meeting on Sep 24, 2024; working closely with CMS executives, and we appreciate how much they are listening to our concerns

and are receptive to our feedback; Q&A doc and short recap of the community engagement meetings will come out in today's Dragon Dispatch; 10 Dilworth parents spoke at the last BOE meeting; questions about the breakdown of the MGD students was brought up - Ms. Crawford will reach out to MGD principal for numbers
